1. Minutes of Previous Meeting:

2. Matters arising from last minutes

L.McN. War memorial at Tullochgorm. Funding has now been applied for. The path to the memorial may/ may not be included in the funding. L. McN would like to thank Counc. Taylor for his help with this.

2. Agenda

Two items were on the agenda.

1.Police Report.

From Inspec. J. McLeish, Sgt. D. McGeachy,

No crime has been reported in the West Lochfyne area.

Road Traffic collisions have been causing some disruption.

Another warning was issued about "Skimming" devices being placed on cash points. The Bank of Scotland in Inveraray now has an anti skimming device fitted.

"Rural Watch" West LochFyneside. F.B applied and was told that, individuals rather than groups were welcome to apply. S.T in Minard, and F.B in Lochgair have been accepted. Signs are to be placed around West Lochfyne and further details on West LochFyneside website.

F.B asked if Police could carry out speed enforcement as speed seems to be increasing and complaints have been received.

2. Wind Farms

A' Chruach. Wind farms

We are currently waiting for a meeting with Infinis.

F.B reported that tea and cakes in Minard went very well and a large proportion of the local community attended. A report into the results of the survey should be available by end of February.

Question from floor: S. Calderwood. Regarding Lochgilphead involvement in wind farm monies. F.B replied that Lochgilphead will be at "Table" for three years, however at any time groups from Lochgilphead are eligible to apply as long as eligibility criteria are met.

L.McN reported that Garvachy road is in very poor condition and is being used by wind farm traffic. He has spoken to manager about this and a meeting is/was to be held on Thursday 21 January.

Further information has been received about fibre optic cable being laid alongside Garvachy Rd this also appears to causing damage and mess to the road.

Question from floor: W. Lamb. Regarding who and how applications were being dealt with. F.B explained the "Constitutional bodies" and what this entails.

Question from floor: I. Smith. Regarding the funding of company carrying out survey, Community Enterprise. F.B explained this was not from wind farm monies but from government funds.

No news from any other wind farms.
